THROUGH THE NEIGHBORHOOD REVITALIZATION PROGRAM, WE ALSO PROVIDE CRITICAL EXTERIOR REPAIRS TO QUALIFYING HOMEOWNERS. THESE APPLICANTS GO THROUGH A SCREENING PROCESS AND PARTICIPATE IN BUILDING OR REPAIRING THEIR HOME. IN 2014, HABITAT BUILT AND SOLD 35 HOMES AND CONTINUED THE CRITICAL HOME REPAIR PROGRAM WITH 20 HOMES UPON COMPLETION OF THEIR SWEAT EQUITY.
